# Highway improvements to Jeffrey Road/Crescent Road, Great Baddow - Frequently Asked Questions

Jeffrey Road and Crescent Road have been identified by Essex County Council as roads which would benefit from highway investment to improve them. A programme of works has been made to:

- Introduce highway drainage to the full extent of Jeffrey Road and Crescent Road.
- Widen the carriageway.
- Widen footways.
- Reconstruct the vehicle crossing points

We may also undertake some clearance of overhanging vegetation in order to facilitate these works.

#### 1. Why are these works taking place now?

The roads have been identified as needing improvement and funding has been made available for the works to be undertaken.

#### 2. How long will the work take?

Approximately 6 months for the overall scheme. However the works are being undertaken in phases to limit the number of houses being affected by the works at any one time.

The timescales could be subject to change, for example if affected by weather conditions or if unexpected issues are discovered whilst works are under way.

#### 3. When will the works take place?

The majority of the works will be undertaken during the day time, and between the hours of 7.30am and 5.00pm.

#### 4. Will there be nightworks?

To minimise congestion on Maldon Road at peak times some overnight working/lane restrictions may be needed to support the installation of drainage works. Details of the dates will be available on the website and on site signage as appropriate.



#### 5. Will the works be noisy?

Regrettably there will be some noise and inconvenience while work is underway. Noisy works such as the excavation of the carriageway will be undertaken during the day time. There will also be some unavoidable noise from vehicles.

Some of the works planned for Maldon Road may be undertaken overnight to support drainage works. This will involve excavation of the carriageway. Where possible we will take the noisiest operations prior to 11pm however works will continue for the remainder of the shift.

## 6. Why do you need to completely close the section of road being reconstructed?

Excavations of the carriageway will range from 70cm deep to 100cm. With excavations this deep it is not possible to provide an adequate safety zone to separate vehicles from the working area.

## 7. Will it be possible to park my vehicle on my driveway if my property is within a section of the road closed?

Please find alternative parking outside of the closed section of road being reconstructed while the works are in front of your property. The work will involve excavation of the carriageway/footways, installation of drainage pipes and other utility services which may physically restrict safe vehicle access.

#### 8. Why are you undertaking the works section by section?

The works are phased to limit the amount of time residents are personally inconvenienced by the works.

# 9. Will emergency services still have access to the closed section if required?

Emergency services have been informed and we will continue to update them with progress of the scheme.

Engineers have experience of working with emergency services to ensure they have information about the works and appropriate emergency access to support residents within a closed section of road.

#### 10. How will my waste bin recycling collections be affected?

Please put your recycling waste on the boundary of your property. The recycling team will then be able to access the waste via the identified pedestrian routes during the works.



# 11. What happens if I am expecting a large delivery (eg. furniture) during the closure, what should I do?

Please discuss specific requests in advance with our onsite team who will support residents as much as is reasonably practical.

Please inform visitors and supplier in advance of any road restrictions in place so they can best accommodate any deliveries to your property.

# 12. Pedestrians including school children pass through Jeffrey Road/Crescent Road when walking to school - what route should they take?

Diversions will be signposted to direct pedestrians to alternative routes, bypassing the works and the closed section of road. This information will be available on the website.

# 13. Will I be able to freely access my property when the closure fronts my property?

Pedestrian access to properties will be maintained for those who fall within the closed section of road under construction. If you have any special access requests to support personal mobility (for example, require the use of a mobility scooter) then please contact the site team on the telephone number provided on your resident letter, at your earliest convenience so we can best accommodate you.

#### 14. How will you keep residents updated?

Residents of Jeffrey Road and Crescent Road will be contacted with further details prior to works starting immediately outside their property (when vehicular access is not possible by the road being constructed).

A contact telephone number of the site team who also will be provided to support residents affected during the works.

On site signage will be updated to reflect the works.

Updates will also be made to the Other Scheme pages of the website to provide further information.
