Width is unspecified, except for the final 80mt, along the western side of the farmyard, which has a width of 1,5mt. 79 NW 7295	17	FP	From footpath 16 and the road west of Downham House in a southerly direction to the road north of St Margaret's Church.		
79 NW,SW 7395-7394	18	FP	From the road west of Downham Hall in a south- easterly direction to the parish boundary where it continues as footpath 80 in Basildon UD.		
79 NW 7396	19	FP	From Brock Hill in a general westerly direction along the southern edge of Harrow Wood to join the road north-east of Sudbury's Farm and footpath 20.
