


(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY TO BE EXTINGUISHED

A part length of Footpath 4 Great and Little Leighs of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 57344,21937 where it connects to Footpath 2 Great and Little Leighs running in a south easterly direction within a wooded area for a distance of approximately 207 metres to point **B** at grid reference 57362,21926 where it meets the northbound lane of the A131. A further section of Footpath 4 commencing at point **C** at grid reference 57364,21924 where it connects to the southbound lane of the A131 running in a south easterly direction between hedges for a final distance of approximately 78 metres to point **D** at grid reference 57371, 21920 where it terminates at its connection with London Road.
