This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the owner and lessee of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The Applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Harlow District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated at Kennels Lane known as Footpath 166 in the District of Harlow and shown by a bold continuous black line on the order map numbered PROW-21-24 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.

- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated at Kennels Lane known as Footpath 166 in the District of Harlow as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered PROW-21-24 contained in this order.

Existing Route A-B

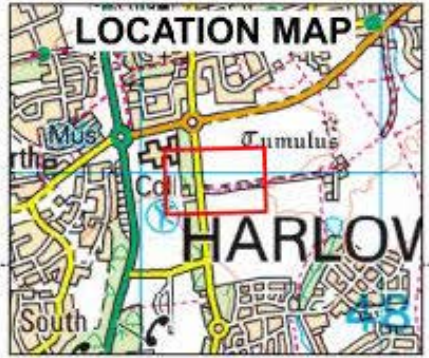
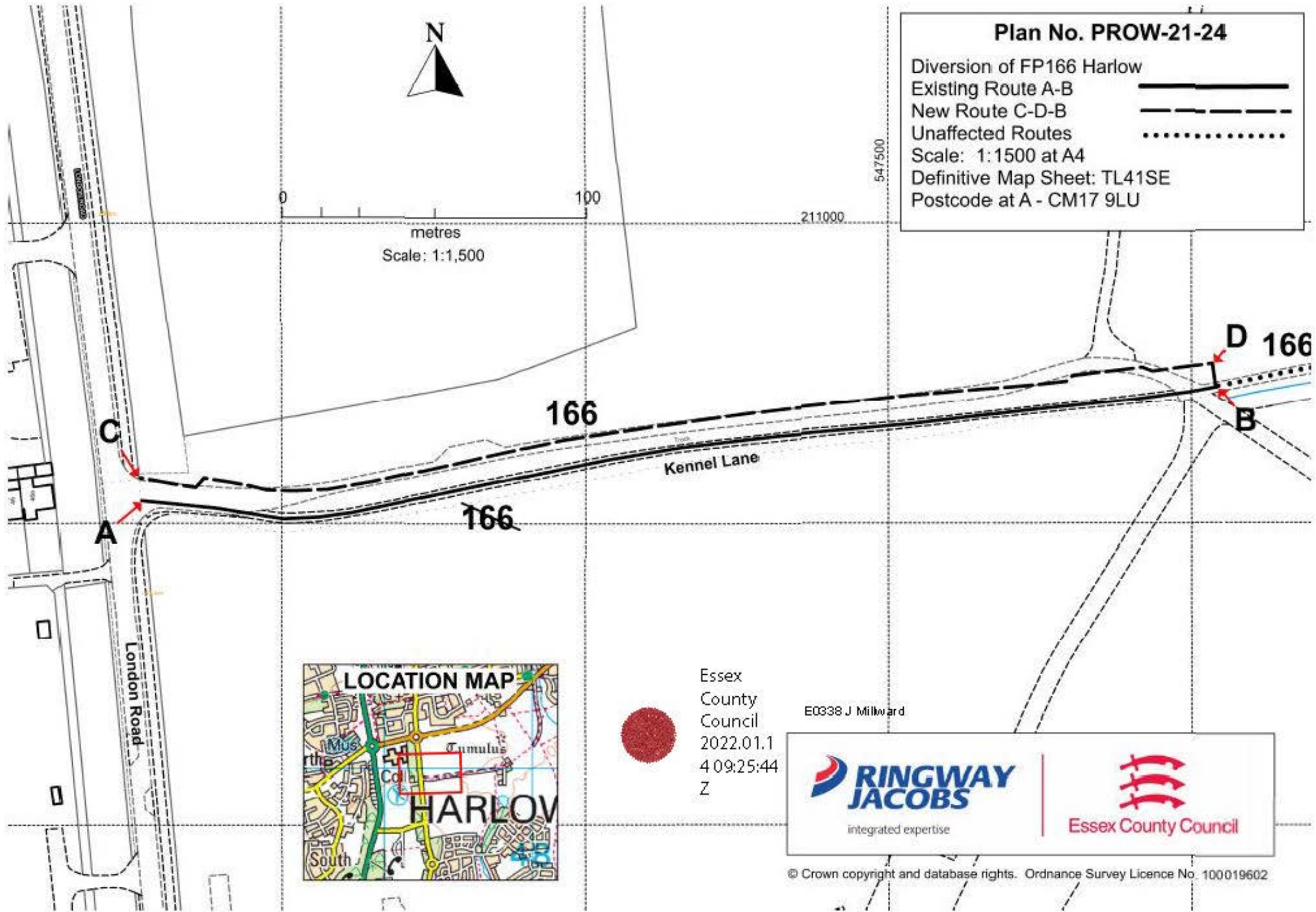
New Route C-D-B

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 166 Harlow of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 547253 210907 at its junction with London Road running in a generally easterly then east north easterly direction for a total distance of approximately 357 metres to point **B** at grid reference 547608 210946.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing at Point **C** at grid reference 547253 210915 on the northern side of Kennels Lane running in a generally easterly then east north easterly direction for a distance of approximately 359 metres to point **D** at grid reference 547606 210954 then in a southerly direction for a final distance of approximately 8 metres to the aforementioned point **B**.


