This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Hammonds Estates LLP have agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Chelmsford City Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way situated over land at Hammonds Farm Little Baddow CM3 4BJ in the City of Chelmsford and shown by a bold continuous line on the order map PROW-23-23 rev01 Sep2023 contained in this order and described in Part 1 of the Schedule to this order shall be stopped after 35 days from the date of confirmation of this order.

2. There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated at Hammonds Farm Little Baddow CM3 4BJ in the City of Chelmsford and described in Part 2 of the Schedule and shown by a bold broken line on the order map PROW-23-23 rev01 Sep2023 contained in this order.





