This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated at Stapleford Hall Farm known as Footpath 12 Stapleford Abbots in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-23-28 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated at Stapleford Hall Farm known as Footpath 12 Stapleford Abbots in the District of Epping Forest as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-28 contained in this order.

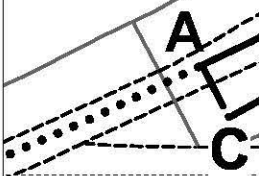

## SCHEDULE

(PART 1)

### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 12 Stapleford Abbots of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55055,19540 running along a private driveway through an electric gate in a north easterly direction passing through a boundary fence for a total distance of approximately 58 metres to point **B** at grid reference 55060,19543 where it continues unaffected.

(PART 2)

### DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running along a natural surfaced path in a south easterly direction for a distance of approximately 4 metres to point **C** at grid reference 55056,19540 then continuing in a north easterly direction for a further distance of approximately 58 metres to point **D** at grid reference 55061,19543 then continuing in a north easterly direction for a final distance of approximately 5 metres to the aforementioned point **B** where it continues unaffected.


