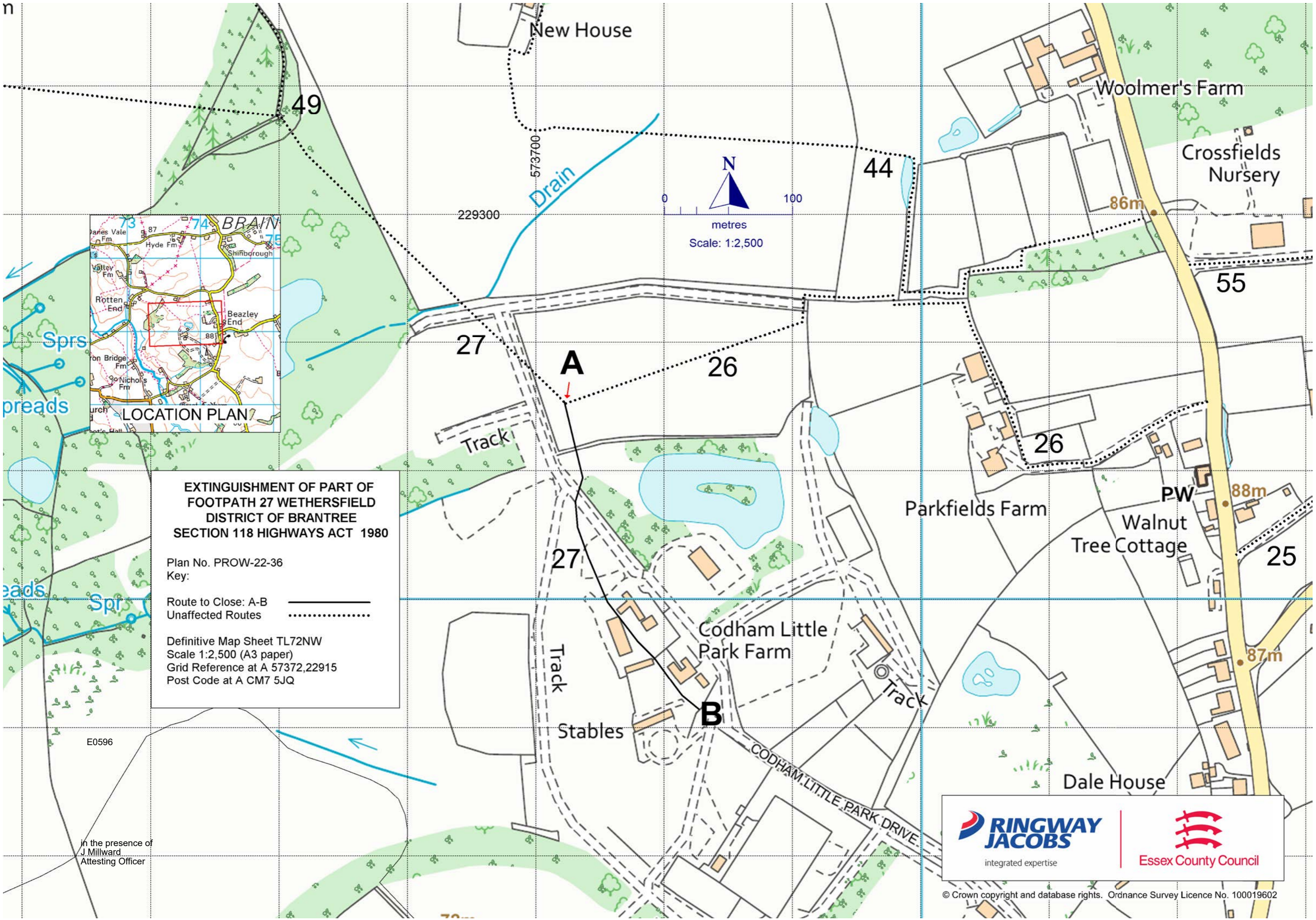

BY THIS ORDER:

1) The public right of way over the land situated at Codham Little Park Farm known as Footpath 27 Wethersfield in the District of Braintree and shown by a bold continuous line on the order map numbered PROW-22-36 contained in this order and described in Part 1 of the Schedule to this order shall be extinguished after 35 days from the date of confirmation of this order.

DESCRIPTION OF SITE OF EXISTING PATH OR WAY TO BE EXTINGUISHED

A part length of Footpath 27 Wethersfield of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 57372,22915 where it connects to Footpath 26 Wethersfield running in a south westerly direction between farm buildings and through a wall for a total distance of approximately 273 metres to point **B** at grid reference 57383,22891 located to the south of farm buildings where it meets the end of the private access track known as Codham Little Park Drive.
