

**The Essex County Council (Various Roads, Mistley)
(Restricted Roads, 30mph and 40mph Speed Limit) Order 202***

The Essex County Council in exercise of its powers under Section 84(1) and (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour on those lengths of road, in the District of Tendring as specified in Schedule 1 to this Order.
2. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on those lengths of road, in the District of Tendring as specified in Schedule 2 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This order shall come into operation on and may be cited as The Essex County Council (Various Roads, Mistley) (Restricted Roads, 30mph and 40mph Speed Limit) Order 202*.
5. 'The Essex County Council (Tendring District) (Restricted Roads) (No.4) Order 2008' is hereby revoked insofar as it relates to the lengths of road, in the Parish of Mistley.
6. 'The Essex County Council (Tendring District) (40mph Speed Limit) (No. 2) Order 2010' is hereby revoked insofar as it relates to the lengths of road, in the Parish of Mistley.

Schedule 1

30mph Speed Limit - Lengths of road at Mistley

B1352 Harwich Road	From its junction with New Road, eastwards to a point 235 metres east of its junction with Stourview Avenue, a distance of approximately 1612 metres.
Long Road	From a point approximately 321 metres east of its junction with Colchester Road (the parish boundary), eastwards for a distance of approximately 78 metres.
New Road	From its junction with The Walls/High Street, south-westwards to a point approximately 171 metres west of its junction with Trinity Road, a total distance of approximately 1433 metres.
The Walls	From a point approximately 704 metres east of its junction with Quay Street, eastwards to a point approximately 777 metres east of the said junction with Quay Street, a total distance of approximately 73 metres.

Schedule 2

40mph Speed Limit - Lengths of road at Mistley

Long Road	From a point approximately 171 metres west of its junction with Trinity Road, westwards for a distance of approximately 287 metres.
B1035 Clacton Road	(i) From its junction with B1035 New Road/Long Road and Trinity Road, southwards for approximately 346 metres (ii) From a point approximately 660 metres south of Steam Mill Road, for a distance of 1025 metres in a southerly direction.
